**TERMS AND CONDITIONS OF THE SHOOTING GENERATOR VAN  
ASSAM STATE FILM (FINANCE AND DEVELOPMENT) CORPORATION LTD.**

  - a. Up to seven (7) days Rs.3,500.00 per day
  - b. Above seven (7) up-to 15 days Rs. 3,200.00 per day
  - c. Above 15 days up to 24 days Rs.3,000.00 per day
  - d. Above 24 days Rs.2,500.00 per day
  - e. For package 45 daysRs.99,000.00 (Fixed)
2. RELAXATION FOR TRANSIT
  - a. Above 7 days One day
  - b. Above 15 days Two days
3. The payment will have to make as follows:
  - a. Up to seven (7) days full payment will have to be made at the time of Booking.
  - b. Up to seven (7) days Rs.12,000.00 will have to be paid at the time of booking and the rest amount will have to be paid before Transit of the Vehicle for Shooting.
4. The Authority reserves the Right to make extension of Booking subject to availability of the Vehicle and after receiving full payment of extension period.
5. The P.O.L etc. of the Shooting Van and the Generator will have to be bear by the Party.
6. The Party will have to bear the over times allowance of the Staff of the Shooting Generator Van after eight (8) hours duty.
7. The Party will have to part the Shooting Generator Van at a proper place at the outdoor location
8. The Hirer will be responsible for any damage of the Shooting Generator Van or its equipments cost by the Members of the Production Unit
9. In case cancellation of Booking of full package the Hirer has to inform the Authority prior to sixty days in advance, otherwise Booking Amount will be forfeited. In case of cancellation of Booking within short period the Authority reserves the right of taking decision of forfeiture of the booking Amount.
10. Any problem arises in regard to the Service of Shooting Generator Van the Hirer will have to inform the Authority immediately.
11. The Caretaker of the Shooting Generator Van will submit a report countersigned by the Hirer.
12. The Hirer and the Caretaker will not insist the Driver for driving of the van through an improper road.
13. The Generators of the Shooting Van should not be operated continuously for more than six (6) hours.
14. The Hirer will not Board any other equipments without the permission of the Authority in the Shooting Generator Van.
15. The Person signed the Booking Form on behalf of the production will be held responsible for Violation of the Terms and Conditions mentioned above.
16. The Corporation will not responsible for any sudden mechanical defects of the Van and Generator.
